

## Private Domestic Relations Arbitrators

The following arbitrators have informed the 9<sup>th</sup> JAD ODR they are available to serve as arbitrators in Domestic Relations cases should the parties voluntarily agree to use the **binding** arbitration process. This list is provided only as a resource and is not exclusive. Should parties select an arbitrator from this list, or any other resource, this binding arbitration will be a private process and cannot be facilitated by the 9<sup>th</sup> JAD ODR. The 9<sup>th</sup> JAD ODR program is a court-annexed program and is not allowed to be involved in any part of a binding arbitration process. Binding arbitration in Domestic Relations cases is voluntary and is not a Court supervised method of ADR.
